NOTES TO STUDENTS

1. The Enhancement Measures for CEF has been implemented since 1 April 2019. Under the enhancement measures, students are required to sign upon course enrolment agreeing their personal data and any other information such as those in relation to the application for the course will be disclosed to the Labour and Welfare Bureau (LWB), and its agent(s), and the Office of CEF (OCEF) for the purposes of fees reimbursement and audit inspection if they apply for fees reimbursement under the CEF.
2. Students must submit the completed form before the commencement of the programmes, i.e. by 6 September 2026 for the subject(s) from Semester One 2026/27. If students do not submit the completed form during the programme registration, they may submit it to cpce.ar@cpce-polyu.edu.hk (email). If we do not hear from you by the aforesaid deadline, we would assume that you do not wish to apply for CEF reimbursement. In such case, your application for “CEF Letter of Certification” after your completion of the CEF course will not be accepted.
3. If students do not consent to the disclosure of their personal data to the Specified Public Authorities before attending the course(s), the OCEF would not process the application for fees reimbursement.
4. In respect of any courses for which the fees are to be reimbursed, upon seeking reimbursement of the fees, the applicant must not have obtained any other public funds or assistance under any other publicly-funded financial assistance schemes for the same course, such as grants or loans from the Financial Assistance Scheme for Post-secondary Students administered by the Student Finance Office.
