- Applicants applying for a refund of fee should complete the two application steps on or before the deadlines stipulated overleaf. Late applications or applications without the supporting documents required will NOT be processed.
- You must attach a photocopy of the confirmation email or offer letter issued by the institution which has offered you a study place of UGC-funded full-time Higher Diploma (Note: only applicable to sub-degree programmes offered by PolyU HKCC) / Bachelor's Degree programme OR a Bachelor's Degree programme funded by SSSDP (Note: Enrolling on an SSSDP-funded Higher Diploma programme is NOT eligible for a refund), and the payment receipt or registration proof showing that you have already registered with that UGC-funded / SSSDP subsidised programme OR payment proof (a copy) of the tuition fee for the programme offered by the institution, e.g. debit note receipt, deposit receipt, payment reference number of PPS / Internet Banking Bill Payment Service, or ATM customer advice. You must also bring along the originals of such letters and documents for verification.
- For your convenience, HKCC / SPEED will collect your bank account information when you submit your refund application. However, this does not constitute a successful application. The bank account should be in the name of the student. If it is a joint account, the student should be an alternative party. Any credit card numbers / accounts are NOT accepted.
- You will be informed of the application result in writing within 21 working days upon receipt of your completed application with necessary supporting documents.
- The refund will be made through the Finance Office of The Hong Kong Polytechnic University in 6 to 8 weeks upon approval. Please be reminded that the refund will only be made after you have returned your HKCC / SPEED Student Identity Card and cleared all outstanding procedures with HKCC / SPEED, if applicable.

If you have been admitted to a programme listed below via JUPAS:

- a UGC-funded full-time Higher Diploma* / Bachelor's Degree programme[^] (programmes offered by Hong Kong Metropolitan University and The Hong Kong Academy for Performing Arts are not UGC-funded), OR
- a Bachelor's Degree programme funded by Study Subsidy Scheme for Designated Professions / Sectors (SSSDP)⁺ (Note: Enrolling on an SSSDP-funded Higher Diploma programme is **NOT** eligible for a refund)

You may apply for a refund of the registration fee by completing the two application steps on or before the deadlines stipulated in the Freshman Guide. An administrative fee of HK\$250 will be deducted, and the application fee is non-refundable and non-transferable. HKCC / SPEED reserves the right to make the final decision.

* The refund criteria for applicants who have accepted an offer through JUPAS for a full-time UGC-funded Higher Diploma programme are applicable only to sub-degree programmes offered by PolyU HKCC, and are not applicable to full-time 4-year undergraduate programmes offered by PolyU SPEED.

[^] UGC-funded programmes, i.e. University Grants Committee-funded programmes, for the 2026/27 academic year are provided by the following institutions: City University of Hong Kong, Hong Kong Baptist University, Lingnan University, The Chinese University of Hong Kong, The Education University of Hong Kong, The Hong Kong Polytechnic University, The Hong Kong University of Science and Technology and The University of Hong Kong. Please note that programmes offered by Hong Kong Metropolitan University, including those that can be applied through Joint University Programmes Admissions System (JUPAS), and The Hong Kong Academy of Performing Arts (HKAPA) are not UGC-funded programmes.

⁺ Study Subsidy Scheme for Designated Professions / Sectors (SSSDP) is a subsidy scheme starting from the 2015/16 academic year to subsidise up to 3,000 students per cohort to pursue designated full-time locally-accredited self-financing undergraduate programmes in selected disciplines. Enrolling on an SSSDP-funded higher diploma programme is not eligible for a refund of the Registration Fee (and the remaining tuition fee, if applicable).
